DECLARATION OF INTEREST

RESOLVED:

139/19MR. SAUL BURTON, HALKYN MOUNTAIN LIVING LANDSCAPE OFFICER

The Chairman welcomed to the meeting Mr. Saul Burton who provided an outline of his role and duties working alongside the Halkyn Mountain Ranger Mrs. R. Watson.

His appointment was being funded for 3 years following receipt of a £400 grant which he would manage for the delivery of improvement projects on the common.

Saul also advised that he had attended the recent meeting of the Best Kept Village Working Group advising that he would be able to provide support to a number of proposed initiatives. One project is to provide bird nesting boxes with kits being provided for the schoolchildren of Brynford CP School to assemble and erect.

The Chairman thanked Mr. Burton for his attendance.

140/19COMMUNITY POLICING

Further to Minute No. 132/19, the Chairman welcomed to the meeting PCSO Simon Griffiths of the Rural Crime Team, North Wales Police.

Following reports of increasing damage and nuisance being caused by motor cycles being ridden over the common, Simon gave an outline of a proposed awareness and action day being planned by the police which is due to take place on the common in the near future.

The action would involve the deployment of a number of police personnel, motor cars, motor cycles and the use of a drone.

Simon further advised that in other similar situations cameras had been deployed to gather evidence of the activities and that he would make an application for funding a camera unit should the Council wish to manage the deployment of the unit.

The Chairman thanked Simon for his attendance.

141/19STREETSCENE SERVICES

Mr. Neil Hickie, Area Supervisor, Streetscene Services provided an updated maintenance schedule of planned highway works for the area.

Members reported a number of issues regarding potholes and poor road surfacing. Neil further advised that white lining programme work would commence in April. The Chairman thanked Neil for his attendance.

142/19BEST KEPT COMMUNITY COMPETITION 2019

Councillor D. Jones reported that a further project working group meeting had been held on the 26th February, 2019 which was attended by a number of local residents. Mr. John Ward had outlined a number of projects that he had been undertaken and potential future projects.

As reported by Mr. Saul Burton, a project to provide bird nesting boxes was being developed in conjunction with the teachers and pupils of Brynford CP School.

It had also been decided to hold a 'clean up our community event' on Saturday 6th April, 2019. Volunteers would assemble at the village green for 10am. Mr. Neil Hickie had agreed to provide hi vis jackets, bin bags, gloves and litter pickers.

Members agreed that a banner be provided and located on the village green in order to publicise this event. Councillor D. Jones agreed to organise this.

Councillor L. Rosedale advised that he had requested support from the Holywell Army Cadets and was awaiting a formal reply.
