### 06/22 MINUTES

# 07/22 STREETSCENE SERVICES

Flaxfield Close, Calcoed – Vehicles parking on greenspace.

Councillor N. Hughes reported that the vehicle had been moved to a more appropriate location.

# 08/22 CODE OF CONDUCT TRAINING FOR ALL MEMBERS OF THE COUNCIL

The Clerk reported that Flintshire County Council had advised that Code of Conduct Virtual Training events were being provided during May and June. The Council had also been advised that under the Local Government and Elections (Wales) Act 2021, all members were required to attend the training. The Clerk advised that he would confirm the training date and details.

#### 09/22 COMMUNITY LITTER PICK BRYNFORD COMMON SATURDAY 23rd APRIL

The Clerk reported that the event had been very well supported with 25 residents turning out on the day with some using their own vehicles including a tractor. Large areas of the common had been cleared of litter.

Holywell Golf Club had very kindly provided refreshments for all the volunteers. Members requested that letters of thanks be sent to the supporters of the event.

#### 10/22 LOCAL GOVERNMENT AND ELECTIONS (WALES) ACT 2021

Further to Minute No. 151/22, the Councillor L. Rosedale reported that he had discussed the specifications and costings with Mr P. Jones Holywell Computers, and confirmed that the proposed specification would enable persons to join the meetings by virtual means and the Council to return to face to face meetings. The Clerk reported that Ysceifiog Community Council had agreed to finance 50% of the cost of the IT equipment.

#### **RESOLVED:**

That the Clerk proceeds with the procurement of the IT equipment and installation of the required software systems by Holywell Computers.

# 11/22 COMMUNITY POLICING

Further to Minute No. 152/22, the Clerk reported that a response had been received from PCSO C. Freel following the Council's request for a site visit at BoWeld Truck Bodies on Milwr Road.

PCSO Freel reported that management advice had been provided to the concerns being raised over the unloading of heavy goods vehicles on Milwr Road and that he was waiting for a further response from the Operations Manager following the meeting.

PCSO Freel further advised that should he receive any further evidence or complaints, then he would return for further discussions with them.

Members reported that the highway was still being used as a parking area for offloading vehicles being transported to the unit.

The Chairman requested that members ask residents to record any further incidents which could be provided to PCSO Freel for further consideration.

# 12/22 INTERNAL AUDIT OF ACCOUNTS FOR THE YEAR 2021/22

The Clerk reported that JDH Business Services Ltd, the Council's appointed Internal Auditor, had approved and completed the audit of accounts for the year 2021/22.

Copies of the Audit Report had been provided to members. The audit findings and recommendations were noted and would be implemented by the Council.

# 13/22 <u>COMMUNITY COUNCIL ELECTIONS 5<sup>TH</sup> MAY 2022 - FILLING OF VACANCIES BY CO</u>OPTION

Further to Minute No. 155/22, the Clerk confirmed that following the Council elections, the three vacancies that exist on the Council may be filled by co-option. The Council agreed that Notice of Co-Option be placed on the Public Notice Board and Council Website. Applications received would be considered at the June meeting of the Council.

#### 14/22 BRYNFORD RECREATION GROUND HIRE OF FOOTBALL FACILITIES

Mr G. Roberts the Manager of Brynford Rams Football Team had written to the Council advising that he would not be hiring the football ground for 2022/23 due to the team being disbanded. He conveyed his thanks to the Council for the support that the Council had given the team over the past years.

The Clerk reported that Mr T. Doyle, Manager of Holywell Juniors Football Team, had contacted the Council requesting the hire of the football ground for the 2022/23 season.

Members agreed to the hire of the facility subject to the satisfactory completion of the hire agreement application.

# 15/22 BRYNFORD CHILDREN'S PLAY AREA - UPGRADING MATCH FUNDING SCHEME

Aura Leisure Services Officer Mr R. Roberts had advised the Council that the agreed provision of the new boundary fence and added items of play equipment had been completed.
