20/22 ITEMS RAISED BY MEMBERS OF THE PUBLIC IN RELATION TO THE BUSINESS ON THE COUNCIL AGENDA

No members of the public were in attendance.

21/22 DECLARATION OF INTEREST

No declarations of interest were declared in respect of the business on the agenda.

22/22 MINUTES

RESOLVED:

That the minutes of the Annual General Meeting held virtually on the 10th May 2022 were approved as a correct record.

23/22 STREETSCENE SERVICES

The Chairman welcomed to the meeting Mr Neil Hickie, Area Supervisor, Streetscene Services.

Neil provided a report showing the results of the recent traffic speed survey undertaken by the Highway Authority. The survey location was on the B5121 at the top of Brynford Hill.

The findings of the survey indicated that most traffic speed was within the designated speed restrictions.

However, further consideration were being given to the possibility of extending the existing 30pmh zone.

Flaxfield Close, Calcoed – Vehicles parking on greenspace: Neil advised that he had spoken to the resident, requesting that vehicles are not parked on this greenspace. Overgrown trees on greenspace: Neil advised that the trees had been inspected and that no further action was required at the current time.

Milwr Road - Overgrown cherry trees encroaching onto the highway verge: Neil advised that the pruning of the trees would be included on the winter works schedule.

The Chairman thanked Neil for his assistance and support with the community litter pick day held in April and for attending the meeting.

24/22 BRIDLEWAY BYWAY - NAID Y MARCH, BRYNFORD

Members reported that the bridleway had been obstructed with gates and sheeppen panels causing a nuisance to horse riders and walkers.

RESOLVED:

That this matter be reported to the Rights of Way Department, Flintshire County Council.

25/22 BRYNFORD RECREATION GROUND

Mr Tony Doyle Manager of the Holywell youth football team had advised that he wished to redecorate the interior of the football changing rooms.

Members agreed to the request and the Council would reimburse the cost of painting materials.

The Council had been advised that Mr David Parry has been grass cutting on the recreation ground. He has requested if consideration could be given for a further community litter pick and the painting of the football field boundary railings.

Members considered the request and agreed to make further investigations regarding the painting of railings. It was also agreed that the Council would reimburse Mr Parry for any fuel costs.

It was also reported that on the Pentre Halkyn side of the recreation ground, excavations were being undertaken to form a BMX Cycle track.

Members requested that this be brought to the attention of Countryside Services, Flintshire County Council.

26/22 ENCLOSURE OF COMMON LAND CALCOED LANE BRYNFORD

The Clerk reported that he had received further enquiries as to the enclosure of the above land. It has been reported that weed killer was applied to the land that may cause harm to grazing animals.

Members requested that this matter be brought the attention of Legal Services, Flintshire County Council.

27/22 CODE OF CONDUCT TRAINING FOR ALL MEMBERS OF THE COUNCIL

Councillors L. Rosedale, T. Stephenson and P. Wahl confirmed that they had attended the training event. Cllr Rosedale advised that a recording of the training event was available through the County Council. Members requested that the link to the recording be sent to all members and enquires then made as to whether watching the recording then qualifies as attendance of the training event.
